Japan, a country where ancient tradition coexists with cutting-edge modernity in perfect harmony, has long captivated the Western imagination. Once closed to

outsiders and regarded as mysterious, today it offers travellers a wealth of cultural opportunities just waiting to be discovered. With ROMTravel, we'll explore Japan's rich tapestry of history, art, architecture, cuisine, and everyday life. Beyond the well-trodden tourist paths, we'll uncover the authentic Japan – vivid, intricate, and unforgettable – in a way that only ROMTravel can deliver.

In the modern capital city of Tokyo, our journey will begin by delving into ancient Japanese art and culture at the Tokyo National Museum, the largest and oldest museum in Japan. With this foundation, we'll continue to explore Tokyo's famous temples, markets, neighbourhoods, modern art and pop culture.

Before leaving Tokyo, we will enjoy a day excursion to Nikko to visit the historic shrines and temples of this UNESCO World Heritage site. November is fall foliage time and the brilliant colours of the gingko trees and Japanese maples will provide a spectacular background for our travels.

Everyone wants to experience the famous "bullet" trains of Japan...and so we shall! Travelling by Shinkansen and express trains, we will head to

Matsumoto through the Japanese Alps to visit the impressive 16th-century Matsumoto Castle and striking works by Yayoi Kusama in the local art museum. The day will conclude with a relaxing overnight stay at a traditional ryokan with onsen (hot springs) baths.

Our journey will next take us to Takayama. We will stop along the way to stroll a portion of the historic Nakasendo Trail that once connected Kyoto to ancient Edo (present-day Tokyo). This is peaceful, natural Japan at its autumnal best. Takayama is the perfect place to explore traditional wooden buildings and the work of local artisans including the lively riverside Miyagawa Morning Market. Here we will tour a boutique sake brewery to learn about the creative process of transforming rice into smooth sake.

After a beautiful drive through the central Alps, we will be transported back in time while visiting Shirakawa-go,

famous for pitched roof farmhouses called "gassho-zukuri".

It will be a short drive onward to the west coast and Kanazawa, the "City of Arts and Gardens" in the Ishikawa Prefecture. Kenrokuen Garden, one of Japan's most beautiful gardens, is on our must-see list, as well as the 21st-century Museum of Contemporary Art and the culinary "hot-ticket" speciality of gold-leaf-covered ice cream for which the city is known.

We will be transported again on the Shinkansen, where the final leg of our journey will bring us to Kyoto. The former capital city of Japan is still known today for traditional Japanese culture. Highlights will include the Kinkakuji Golden Pavillion, Ryoanji Temple and the spectacular Nijo Castle and Ninomaru Palace.

We will slow down to enjoy a tea ceremony and have a chance to explore Kyoto's walkable neighbourhoods.

With Kyoto as a home base, we will embark on two short daytrips. In the Shigaraki Mountains, we will explore the famed Miho Museum and visit the historic pottery town of Shigaraki. We'll make a second excursion to the ancient city of Nara, another UNESCO World Heritage site. Here we will stroll the sacred grounds where we can feed some of the over 1,000 deer designated as national treasures. This will be followed by a private visit to a traditional shrine. Our final night will be spent in Kyoto before departures either homeward or on to other parts of Japan on your own.

Trip Itinerary and Highlights

Day 1 Arrival in Tokyo

Individual arrivals at either Tokyo's Narita International Airport (NRT) or Haneda Airport (HND). Transfers from airport to hotel.

Day 2 Introduction to Tokyo

Our first day in Tokyo will be filled with discovery. Begin at the **Tsukiji Outer Market**, a bustling maze of stalls where

seafood, produce, and specialty ingredients showcase Japan's culinary heritage. More than a market, it is a living reminder of how central food is to Japanese culture.

At the **Tokyo National Museum**, explore one of the world's finest collections of Japanese art, from prehistoric figurines to masterful screens, woodblock prints, and elegant kimonos. Visit **Asakusa's Senso-ji Temple**, Tokyo's oldest and most iconic Buddhist temple, with its grand Kaminarimon Gate and bustling **Nakamise-dori**, lined with shops offering traditional crafts and sweets.

Stroll through Yanaka Old Town, a charming district of narrow lanes, small temples, and artisan shops that preserves the spirit of old Tokyo. This evening, gather for a traditional Japanese welcome dinner, a perfect introduction to the flavours of our journey.

Day 3 Nikko

Today we will visit the **historic shrines** and temples of **Nikko**, a UNESCO World Heritage site. Here we'll see sophisticated techniques in architecture,

engineering, and crafts dating from the mid-1600s. The palatial homage dedicated to Tokugawa leyasu – shogun, general and the third of three "Great Unifiers" of Japan – awaits us here. The splendour of this lavishly decorated mausoleum is the origin of the noted Japanese saying, "Never say you're content until you've seen Nikko".

Day 4 Tokyo's Contemporary Art Scene Today will be devoted to Tokyo's cuttingedge art and design. At the Mori Art Museum, discover innovative contemporary works from Japan and around the world, followed by sweeping city views from the Sky Deck. At the 21_21 Design Sight, explore thoughtprovoking exhibitions in a striking Tadao Ando-designed building. The Suntory Museum of Art highlights traditional Japanese aesthetics through exquisite objects of daily life. Enjoy lunch on your own at Tokyo Midtown Galleria, a stylish complex of cafés and boutiques. The

afternoon will be at leisure before we gather this evening for dinner.

Day 5 Tokyo to Matsumoto

Today we will journey by bullet and express train into the Japanese Alps, arriving in the captivating city of Matsumoto. Explore the striking 16th-century Matsumoto Castle. Its elegant black-and-white façade is considered to be one of Japan's most beautiful and best-preserved. Stroll the atmospheric Nakamachi Street, where traditional "kura" (storehouses) now present craft shops and galleries. At the Matsumoto City Museum of Art, admire the vibrant and playful works of renowned artist Yayoi Kusama, who was born in the city.

This evening, retreat to the serene surroundings of a ryokan. Here the ryokan tradition comes to life with tatami-matted rooms, soothing onsen baths, and the gracious hospitality for which Japan is celebrated. Dinner is a highlight: a beautifully presented, multicourse "kaiseki" meal showcasing

seasonal ingredients, served in an atmosphere of refined tranquility.

Day 6 Matsumoto to Takayama

Travel into the Kiso Valley to walk a portion of the **historic Nakasendo Trail**, once the lifeline between Kyoto and Edo.

Our expert guides will bring this feudalera route to life as we stroll past wooden inns, tea houses, temples, and cedar forests, with quiet towns evoking centuries past. Those who prefer stroll to trail will have the chance to explore the beautifully preserved towns of Magome and Tsumago, rich in history and local charm. Continue to Takayama, famed for its Edo-period streets and mountain setting.

Day 7 Takayama

Begin at the lively Miyagawa Morning Market, where vendors offer seasonal produce, regional specialties, and hand-crafted goods. At the Yatai Kaikan Hall, admire the elaborately decorated floats of the celebrated Takayama Festival, some dating back centuries. The Kusakabe Mingeikan Folk Museum, set

in a stately 19th-century merchant's house, reveals the artistry of everyday life. A walking tour of the atmospheric **Sanmachi Suji district** showcases preserved wooden houses and artisan workshops. This will be followed by a visit to a boutique **sake brewery** to learn about and taste the artistry of Japan's most famous libation.

Day 8 Takayama to Shirakawa-go to Kanazawa

Drive through the dramatic Japanese Alps to Shirakawa-go, famous for its distinctive "gassho-zukuri" houses with steeply pitched thatched roofs resembling hands pressed together in prayer. These houses are built without nails with spacious interiors over multiple floors and have been used historically for silkworm farming. Continue to Kanazawa, a cultural gem on Japan's west coast, renowned for its samurai heritage, traditional crafts, and well-preserved Edo-period districts. Explore the Nagamachi Samurai District from the Edo Era (1603 to 1868) and the Nomura-ke Museum, an elegant

samurai residence offering a glimpse into the refined lifestyle of the former warrior class.

Day 9 Kanazawa

Explore the "City of Arts and Gardens", starting at the **Kenrokuen Garden**, considered one of Japan's most beautiful. Its tranquil ponds, stone lanterns, and seasonal blossoms are especially stunning during the autumn season.

The 21st-century **Museum of Contemporary Art** showcases cuttingedge exhibitions, including Leandro
Erlich's famous "Swimming Pool"
installation. As we explore the city, we'll
visit artisans maintaining traditional
lacquer making and washi paper
workshops before sampling a playful
local specialty: **gold-leaf-covered ice cream**.

Day 10 Kanazawa to Kyoto

Travel from Kanazawa to Kyoto by bullet and express train. In Kyoto, the cultural

heart of Japan, begin with the shimmering **Kinkakuji Golden Pavilion**, a jewel-like temple reflected in its surrounding pond, symbolizing harmony between architecture and nature.

Nearby lies the **Ryoanji Temple**, home to the world's most famous Zen rock garden. Our guides will interpret the symbolism of its fifteen stones set in waves of raked gravel, "an entire universe in sand and stone".

Day 11 Kyoto: The Miho Museum and Shigaraki Pottery

Venture into the **Shigaraki Mountains** to the striking **Miho Museum**, a masterpiece by architect I.M. Pei, where art, architecture, and nature merge seamlessly. Approximately 80% of the structure is built underground; visitors approach the museum via a scenic path leading through a tunnel and across a suspension bridge, symbolizing a journey into a hidden paradise. The museum's remarkable collection spans tea ceremony utensils, Buddhist art, and treasures from across Asia.

Continue to **Shigaraki**, one of Japan's Six Ancient Kilns, where our visit to the **Museum of Contemporary Ceramics** reveals both traditional Shigaraki ware and the global influence of Japanese ceramic artistry.

Day 12 Kyoto: Sacred Nara

Travel to the ancient city of Nara, Japan's first permanent capital. Among its historic treasures, we'll visit the **Todaji Temple** with its monumental bronze Buddha.

We'll stroll in the spacious **Isuien Gardens** with numerous teahouses scattered throughout and feed some of the over 1,000 deer designated as natural treasures.

In the afternoon, get an authentic glimpse into Japanese spiritual culture. Step into the serene atmosphere of a traditional shrine and discover Japan's rich culture through a warm, personal experience. The visit includes a blessing ceremony in the main hall, followed by a guided tour through the sacred and beautifully landscaped gardens, where you will learn about the symbolic motifs and meanings.

Day 13 Kyoto: Castle and Temple

Start the day at **Nijo Castle,** a window into the culture and history of Kyoto, and a symbol of the power and prestige of the Tokugawa shogunate. The complex is surrounded by massive stone walls and a wide moat, creating a formidable yet elegant impression. Within, the **Ninomaru Palace** features beautifully preserved interiors adorned with opulent sliding doors ("fusuma") painted by artists of the Kano school and famous "nightingale floors" that chirp underfoot to guard against intruders.

Partake in a traditional **tea ceremony** to learn the customs and etiquette of tea serving, the relationship between tea masters and Kyoto's pottery workshops, and the principle of "wabi-chai" (beautifully simple tea). Conclude our journey with a farewell dinner, celebrating the experiences and friendships of our time in Japan.

Day 14 Kyoto to Osaka

- Assumption of Risk: You must be aware that participation in water activities and other activities involves inherent risk, danger and hazards including but not limited to: accidents which occur in the water; slips, trips, falls; overturning or upsetting of watercraft; entrapment by trees, logs, deadfall and/or equipment; falling from watercraft; encounters with domestic or wild animals including bees and jellyfish; high winds or adverse conditions; equipment failure; failure of safety equipment; variation in water conditions, surfaces or currents; negligent first-aid; infectious disease contracted through viruses, bacteria, parasites and fungi which may be

transmitted through direct or indirect contact; the negligence of other participants. Communication on the water, mountains or other isolated territory is difficult and in the event of an accident rescue and medical treatment may not be available.
