In Agra, stand in awe before the ethereal beauty of the Taj Mahal and then continue to Jaipur, the Pink City, known for its regal charm and colourful culture. Travel west to Jodhpur, the Blue City, with its imposing forts and bustling old town, and then slow down in Narlai, a serene village nestled in the Aravalli Hills, where village life offers authentic rural encounters.

Our journey will conclude in romantic Udaipur, with its shimmering lakes and palaces.

Throughout, meaningful interactions, expert-led lectures, curated meals, and thoughtfully chosen accommodations will create an enriching experience, offering insight into India's rich heritage, complex spirituality, and enduring traditions.

Trip Itinerary and Highlights

Day 1 Arrivals in Delhi, India

Welcome to India! Individual arrivals at Delhi's Indira Gandhi International Airport (DEL). Individual transfers to the hotel.

Day 2 Delhi

After meeting our National Guide we'll dive right into exploring the rich cultural layers of the capital. Travel the narrow streets of Chandni Chowk, alive with spice-scented air, before standing beneath the soaring domes of Jama Masjid, the country's largest mosque.

Visit National Gandhi Museum and marvel at Humayun's Tomb, an architectural masterpiece of the Mughal era and a precursor to the Taj Mahal.

We'll enjoy our welcome dinner this evening.

Day 3 Delhi

Travel the broad, ceremonial avenues of New Delhi today, passing monuments like India Gate, Parliament House, and the Presidential Palace.

Visit the National Museum, home to an impressive collection of Indian art and antiquities and step into the vibrant world of Indian contemporary expression at the

National Gallery of Modern Art museum. Later, visit the towering Qutab Minar, a UNESCO World Heritage site and one of Delhi's most iconic landmarks. The stunning minaret stands as a symbol of conquest, faith, and architectural brilliance from the early Delhi Sultanate period.

Day 4 Delhi to Varanasi

We will take a morning flight to Varanasi, one of the world's oldest continuously inhabited cities. Revered as India's spiritual capital, Varanasi is a city of sacred rituals, timeless devotion, and a vibrant tapestry of life along the Ganges River.

We'll visit Sarnath, one of Buddhism's holiest sites, where Lord Buddha delivered his first sermon after enlightenment and tour the nearby Sarnath Museum, housing the Lion Capital of Ashoka, India's national emblem.

Near the ghats, witness the spellbinding evening Arti, a Hindu ritual employed in worship, in which light from a flame is waved to venerate deities. Savour dinner overlooking the river Ganges.

Day 5 Varanasi

Wake early for a sunrise boat ride on the Ganges, a deeply moving experience as the city rouses and daily life unfolds on the riverbanks in a timeless rhythm.

We will visit the sacred Kashi Vishwanath Temple, dedicated to Lord Shiva, and stroll the peaceful grounds of Banaras Hindu University (BHU), one of Asia's largest residential universities.

Day 6 Varanasi to Khajuraho

A short flight to Khajuraho will bring us to the UNESCO World Heritage site, offering a captivating journey into India's golden age of temple architecture and spiritual expression. This ensemble of temples, built between the 10th and 12th centuries by the Chandela dynasty, blends sensuality, divinity, and everyday life with unmatched artistry. Guided by experts, we'll explore the deeper

meanings behind the temples' iconography, architecture, and cosmology. Enjoy an evening of live classical Indian dance at the Khajuraho Dance Festival.

Day 7 Khajuraho to Agra via Jhansi

Travel by coach to Orchha, a captivating archaeological site that echoes the grandeur of medieval India. Visit the Jahangir Mahal citadel and Chhattris. Travel by train to Agra; the journey en route offers a vivid glimpse into the heart of northern India, passing through rural farmlands dotted with small villages.

Day 8 Agra

Today we will take in the mesmerizing Taj Mahal, one of the Seven Wonders of the World, built by Emperor Shah Jahan in memory of his wife Mumtaz Mahal.




Figure 7: Taj Mahal, Agra, India. © Dhirad, Wikimedia Commons, Creative Commons Attribution-Share Alike 3.0 Unported, 2004.

We'll explore Emperor Akbar's Agra Fort, a grand monument which served as a military stronghold and the main royal residence and seat of government for

the Mughal Empire. Its colossal double walls, carved of red sandstone rise over 18 metres (60 feet) high.

We'll visit a marble workshop before enjoying a grand live performance of "Mohabbat-e-Taj," which will take place in the Kalakriti Cultural and Convention Centre, located near the Taj Mahal. The show is a combination of dance, drama, and music, and it tells us the story of the true and eternal love of Emperor Shah Jahan for his wife.

Day 9 Agra to Jaipur

A drive to Jaipur takes us from open farmland with fields of mustard, wheat and sugarcane into the desert state of Rajasthan, where the terrain becomes more rugged and arid. En route, we'll visit the World Heritage site of Fatehpur Sikri, a magnificent red sandstone city built by Emperor Akbar in the late 16th century, one of the finest examples of Mughal architecture and urban planning.




Figure 9: Fatehpur Sikri, India. © A.Savin, Wikimedia Commons, Free Art License, 2016.

Day 10 Jaipur

We'll explore Jaipur, the pink city, with a visit to Jantar Mantar, where ancient astronomical instruments illustrate scientific curiosity of a bygone era, and wander next to the rose-hued facade of Hawa Mahal. A visit to the Anokhi Museum will show how block-printed textiles inspired by Mughal artistry are reimagined for today.

This afternoon we'll see the Amber Fort, a magnificently preserved complex of palaces, halls, pavilions, gardens, and temples. We'll savour dinner at 1135 AD, the exquisite restaurant inside the Fort, offering royal Rajasthani and Mughlai cuisine.

Day 11 Jaipur

Today we will visit Jaipur's lively bazaars, where traditional crafts and vibrant fabrics tempt every sense, capturing the city's timeless spirit and artistic flair. We'll visit City Palace, a former royal residence built in a blend of the Rajasthani and Mughal styles.

The afternoon is at leisure to get us geared up for our longer drive to Jodhpur.

Day 12 Jaipur to Jodhpur

Heading southeast, we'll encounter traditional villages, roadside barber shops, bustling markets, and Hindu temples. Chhatra Sagar, a nearly hundred-year-old reservoir set in 1,400 acres of farmland will be a marvellous spot for birdwatching and lunch on our longer drive today.

Arriving in the brilliant Blue City of Jodhpur, we'll take a guided Heritage Walk through winding alleyways, indigo-washed homes, intricate doorways, and glimpses into the daily lives of local artisans and families who have lived here for generations.

This evening we'll partake in a dinner hosted by a local family.

Day 13 Jodhpur

Marvel at the towering Mehrangarh Fort, one of Rajasthan's most iconic landmarks which Kipling is said to have described as "A palace that might have been built by Titans and coloured by the morning sun". Enjoy sweeping views of the ancient Blue City below and explore the fort's beautifully preserved palaces, richly adorned courtyards, and the dazzling Hall of Mirrors.

We'll visit the peaceful Jaswant Thada, a marble cenotaph set beside a tranquil lake, built in memory of Maharaja Jaswant Singh II.

Day 14 Jodhpur to Narlai

This morning, explore the museum at Umaid Bhawan Palace, which continues to be the home to the former royal family of Jodhpur.

In 2019, ROM hosted an exhibition featuring masterpieces drawn from the collection of the former royal family, most of which were on display outside their

palace setting for the very first time. We'll drive to the quaint village of Narlai, a place still tied to the agrarian rhythms of the day.

Our home this evening will be a magnificent, restored hunting lodge.

Day 15 Narlai to Udaipur via Ranakpur

Our drive to Udaipur will take us to the Ranakpur Jain Temple. This marble complex is noted for the 29 halls supported by 1,444 pillars, each adorned with hundreds of carved figures, with no two alike. A special blessing from the temple priest will be a moving experience.

We'll arrive in Udaipur and gather for a special presentation: "Royalty, Culture and Extravaganza", a fascinating look at Rajasthan's regal traditions.

Day 16 Udaipur

Udaipur, nestled among the Aravalli Hills, enchants with its majestic palaces, tranquil water vistas, and timeless charm. We'll enjoy a boat cruise on Lake Pichola, admiring the stunning perspectives of architectural gems, such as Jag Mandir,

Gangaur Ghat, and the lakeside "havelis" (private mansions).

We'll explore the heart of Udaipur with the magnificent City Palace, a sprawling complex of marble and granite. We'll tour its opulent courtyards, mirrored halls, Crystal Gallery, and museum galleries that showcase centuries of Mewar legacy.

We'll take a guided walk through Udaipur's narrow lanes, past mansions and shrines, bringing us to the lakeside steps before we savour a magnificent farewell dinner overlooking shimmering Lake Pichola.

Day 17 Udaipur and Individual Departures

Dive deeper into the region's artistic soul with a visit to a miniature painting workshop, observing master artists at work. In the early afternoon, we will transfer to Udaipur's Maharana Pratap Airport (UDR) for individual departures.

All costs are quoted are in Canadian dollars.

Trip cost does not include international flight costs to and from your home. Worldwide Quest International can assist with booking flights if you wish.

ROMTravel will not share such contact information with anyone else. For this trip, Worldwide Quest International will not publish a list of participants and will not use photographic images of you for future promotional purposes.

Travel Insurance

It is strongly recommended that each participant obtain adequate trip

All additional costs associated with early departure from the trip will be assumed by the participant, and there will be no refund for the unused portion of the trip. Any costs associated with room or property damage deemed intentional by hotel, resort, and/or transportation suppliers will be the sole responsibility of the occupants and individual travellers.

Any changes in health or medical status must be reported as soon as possible and in some cases may result in Worldwide Quest International withdrawing services and canceling the participant's trip. Group trips typically involve active itineraries, requiring participants to walk approximately 6 kilometres (about 4 miles) per day over uneven terrain including but not limited to: cobblestone streets, staircases, bridges and unpaved walking trails. Unless specifically arranged and agreed upon during the trip planning process, trips are not designed to accommodate physical disabilities or limited mobility.
