Photographing or Copying Materials for Personal Research

Library and Archives patrons may photocopy or use personal devices to take photographs of archival and library materials subject to the following guidelines:

1. Permission to examine and/or obtain a copy of any materials in the ROM Library and Archives does not convey the right to publish. Your rights and obligations with respect to the reproduction by photocopy or other means of copyrighted material, is governed by the *Copyright Act*, RSC 1985, c. C-42, as amended. Researchers must be aware of copyright and must assume full responsibility for clearing reproduction rights and for any infringement of copyright law. The ROM Library and Archives will be held blameless for the infringement of copyright or of publication rights by others due to deliberate or negligent misuse of the permission granted to examine or copy materials in our collections.
2. Photographs or photocopies of materials from the collections of the ROM Library and Archives are for personal research/review only and may not be published, sold, reproduced, transferred, distributed, or otherwise exploited without further permission in writing from the Royal Ontario Museum and/or the copyright owner.
3. Photographs or photocopies of Library and Archives' materials must not be modified and must retain any associated copyright or other proprietary notices.
4. The use of a camera flash is not permitted.
5. Photography or photocopying must not place the physical condition of a book, journal, or archival item at risk. Library and archival materials must be handled with care. Loose material must be kept in its folder in its original order. Reading room staff can assist with the use of book cradles or weights.
6. Reading room staff has the discretion to disallow photocopying or photography if it is disturbing to other patrons or puts any materials at risk.
7. Do not take photographs of other patrons or reading room staff without their permission.
8. If archival or special collections materials will be referenced in the text of your work, an appropriate citation including elements necessary to locate the material must be made. Example: [Identification of item], [Name of fonds or special collection], [Record group or special collection number], Box [box number], File [file number], Royal Ontario Museum Library & Archives, Toronto, Ontario, Canada.
9. If published library materials will be referenced in the text of your work, an appropriate citation including elements necessary to locate the material must be made. Please use a preferred standard citation style (APA, MLA, Harvard, etc.), including the ROM Library location. Example: [Author surname, Author first name] (year of publication). *Title of publication: subtitle of publication*. Place of publication: Publisher. Royal Ontario Museum Library & Archives, Location, Call Number.
